### CURB APPEAL REBATE PROGRAM

Justin Weidl presented a Curb Appeal Rebate application from First Dental Center for new building signage. The signage consists of a set of 20" LED illuminated channel letters, which is discouraged in the Uptown Guide to Good Storefront Design. The rendering provided is hand drawn. Leslie Showers recommended tabling this application until the next meeting and recommended that staff request a higher quality rendering of the proposed signage.

Justin Weidl presented a Curb Appeal Rebate application from J&S Cosmetic Store for new business signage. The signage consists of a wall mounted sign and blade sign. A rendering was provided and reviewed.

### SECURITY REBATE PROGRAM

Justin Weidl presented a Security Rebate application from North Side Housing & Supportive Services for seven (7) security cameras and the associated system with it. Justin Weidl commented that this part of the neighborhood has a lot of foot traffic and a small seating area that is open to the public.

Justin Weidl presented a Security Rebate application from Wilson Abbey for sixteen (16) security cameras and the associated system with it. Justin Weidl commented that this part of the neighborhood has struggled with gang activity and drug dealing. Some of the altercations have effected business at Everybody's Coffee.

#### PUBLIC ART GRANT

Justin Weidl presented a Public Art Grant application from Friends of the Bezazian Library for restoration of the mural on the east facing wall of the library building. The mural was originally painted in 1974 and has faded and deteriorated. The library branch celebrates its 60<sup>th</sup> anniversary this year, and the mural project is intended to mark that occasion.

*Motion to approve Public Art Grant application from Friends of the Bezazian Library for \$3,600.*
